**Important Notes:** Competent Authority of the Board had given a chance to submit the clarification regarding land area possessed by the school, Now, the school has submitted its clarification regarding the same through an email on 06.04.2022 along with land certificate issued dt. 04.04.2022 by Deputy Registrar certifying that Ishwari devi international public school is built on the land measuring 8000 sq mtrs on Khasra number 158/1,158/2, 158/3 and 158/4 also certifying the compactness and lease deed is executed in three parts for 15 continuous years upto 20.03.2034. However, Area of land in the lease deeds is not same ie. 8000 sq meters, 8500 sq meters & 9000 sq mtrs. Whereas, the compactness of land is given only on the land area 8000 sq mtrs in land certificate. Now, school is granted upgradation of affiliation on the following conditions i.e. i) The school will use its land area certified by Deputy Registrar i.e. 8000 sq meters only. Further, school is directed not to use additional land area of 500 sq mtrs declared in second lease deed and 500 sq mtrs area
